Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Issue Date	2020-2024
Topic	Litigation related to labor issues
Summary of Issue	In the last 5 years, El Mejor has had 23 litigation cases regarding unfair or unjustified dismissal of former employees. Plaintiffs request compensation for unjustified dismissal, compensation for lack of notice, salary adjustments, proportional vacations, proportional Christmas bonus, and complementary compensation.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	The total financial value involved in these cases corresponds to less than 5% of the company's annual revenue.
Impact on Stakeholder(s)	Former employees might have been emotionally, mentally and financially impacted.
Resolution	Out of 23 cases, 5 were ruled in favor of the company, 1 against the company, 7 are being appealed and 10 are pending resolution.
Implemented Management Practices	The company constantly updates its processes and verifies its employment contracts to ensure that they are clear and precise regarding working conditions, duration of the contract and grounds for dismissal. In terms of human resources, managers and supervisors are constantly trained on labor laws and on improving practices for personnel management in order to protect the company from contingencies.
