Mutual Understanding &amp; Agreement.</li> <li>The company fully manages the logistics of their gold processing from miners/panners to their manufacturer. Raw gold is sourced directly from a women gold panners group (KPPJ) that consists of 26 indigenous Dayak women committed to not use mercury and only use low impact alluvial mining techniques, such as panning or Manado method. They have an exclusive partnership with the group, pay them a premium price (around 20-30% higher than the village price), and support them through several ongoing programs, like gold refining training, upgrading the smelting facility, providing basic personal protective equipment, and giving scholarships for their children. The melting and refining process is done in partnership with PT Kapit Mas (smelting &amp; alloying) and PT Bukit Mas Mulia Internusa (refining). These companies have undergone an assessment (interview &amp; questionnaire) and visitation from Gardens of the Sun. In addition, they commit to process their gold separately from any other gold for traceability from the women miners to our clients.</li> </ul>

## IMPLEMENTED MGT PRACTICES

- Since September 2020, the company exclusively uses recycled silver from Umicore. This is listed as a Conflict-Free Smelter by the Responsible Minerals Initiative (RMA), Chain-of-Custody certified by the Responsible Jewellery Council (RJC), and in compliance with the LBMA Responsible Ag Guidance. Their metal soldiers from Cookson Precious Metals Ltd and Stuller, Inc are certified. Cookson Precious Metals Ltd is Fairtrade Gold certified, a member of the National Association of Jewellers, members of the RJC and Chain-of-Custody certified by the RJC, also ISO certified (ISO9001, ISO 14001, ISO 45001). Stuller, Inc is RJC certified and received SCS certifications.
- Any diamond sourced by Gardens of the Sun should have been mined and traded in accordance with the Kimberley Process Certificate System.
- The company has transparency to Tier 2 for their silver, gemstones and pearls, and Tier 3 for their Raw Gold. At a minimum, the company ensures that their diamonds and gemstones are conflict free, do not violate human rights, nor employ child labour. To achieve this, they implemented their sourcing policy starting in November 2018 and conducted a country level risk assessment prior to sourcing diamonds and gemstones. They carry out a country level risk assessment to minimise the risk of purchasing stones from conflict areas or countries with a high incidence of human rights violations
- They are developing an internal tool called Gemstone Risk Mapping to help identify visible human rights risks throughout the whole supply chain. The expected outputs from this risk mapping assessment are:
  - Identify emerging or existing human rights risks issues and establish a red list of origin countries. They do not purchase supplies from countries with visible human right violations unless we have solid reasons to believe the materials do not contribute to this
  - Update Directors and colleagues on conflict resolution development from at-risk origin countries
  - Respond to particular issues through strategic donations and support of local organisations
  - Seek collaboration to create a larger impact in improving artisanal and small
- The company has a Gemstone & Diamond Sourcing Manual that outlines the company's sourcing principles, their vision for 100% ethical jewelry, Gemstone Risk Assessment System, company actions to offset risks, and transparency levels.

In 2022, they created a Supplier Code of Conduct. They are currently revamping the supplier scoring system to make the decision-making process more straightforward and transparent. Their target for 2023 is to ask all of their significant suppliers to sign their Supplier Code of Conduct.

Since the conflict begin in Russia in 2022, the company is donating 25% of sales of previously purchased Russian diamonds to Sylni, a Ukrainian organization supporting victims of wartime sexual violence. The company has stopped sourcing materials from Russia and has not purchased any Russian origin gemstones or diamonds since mid 2020.
