Disclosure Questionnaire Category: Animal Products and Services

Topic	Company sources and retails animal products
Summary of Issue	Fish Tales is a company based in the Netherlands that sources and retails fish products (e.g., fresh fish, frozen fish, tinned fish). The company works with local fisheries , and all of their fishing products are certified by the Marine Stewardship Council or the Aquaculture Stewardship Council.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	100% of the company's revenue consists of products from the fishing, fisheries, and aquaculture industry.
Impact on Stakeholders	The fishing industry may have negative environmental impacts on their affected marine ecosystems, e.g., overfishing, loss of biodiversity, pollution. Furthermore, the fishing industry is at risk of human rights violations in their supply chains.
Implemented Management Practices	The company shares a summary of their policies and practices related to sustainability in their annual impact report. Of Fish Tales' product portfolio, ~90% is Marine Stewardship Council (MSC) certified and ~10% is Aquaculture Stewardship Council (ASC) certified. To be MSC certified, fisheries have to meet all three principles of the Marine Stewardship Council's Fisheries Standard. The three principles are sustainable fish stocks, minimal environmental impact, and effective management. To be ASC certified, seafood producers have to meet their farm standards that minimize the key environmental and social impacts of aquaculture. Topics in the farm standards include biodiversity, feed, pollution, diseases, and social. On social, the ASC certification imposes strict requirements based on the core principles of the International Labour Organisation (ILO), these include prohibiting the use of child labour or any form of forced labour. All ASC certified farms are safe and equitable working environments where employees earn a decent wage and have regulated working hours.
