TOPIC	Company manufactures and sells alcohol products
SUMMARY OF ISSUE	Ramborn SA produces alcoholic beverages in the form of cider. It sells cider via distribution channels including wholesale and retail as well as directly at its own facilities. Ramborn complies with all of the regulations and laws related to the sale of alcohol in the jurisdictions where it operates, and earns a material amount of revenue from the sale of alcohol.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	In the previous fiscal year, 87% of the company's revenue was earned from the sale of alcohol.
IMPACT ON STAKEHOLDER(S)	Alcohol may have a negative impact on the health and well-being of individuals and their communities
IMPLEMENTED MGT PRACTICES	All Ramborn branded communications must abide by the ethical code provided by the Commission Luxembourgeoise pour L'Éthique en Publicité (CLEP): http://www.clep.lu/code-dedeontologie/ In particular, special attention must be given to Chapter II Article 2: "Alcohol advertising will not encourage irresponsible and excessive consumption. It will not speak directly to minors and will avoid their representation in its message. In addition, it will avoid any connection with the driving of a vehicle." Ramborn's marketing must not imply that any Ramborn products offer any health, therapeutic, dietary, functional or performance benefits. It must also not imply any energy or endurance benefits, nor that alcohol is the catalyst for any change in mood or state. Exceptionally, the Ramborn Cider Haff as a tourist destination and educational centre may engage and depict families and university students, exclusively for the purposes of education around and cultural revival of meadow orchards. No alcohol may be mentioned in association with persons below the legal purchase age.
OTHER MANAGEMENT COMMENTS	The company has an age verification request on their website. The company affixes all mandatory declarations to their products on the product label.

TOPIC	Water Intensive Industries
SUMMARY OF ISSUE	As a beverage manufacturer, Ramborn SA operates in an industry that is water intensive. Aspects of the industry that make it water intensive include the brewing process, reduction, and cooling.
IMPACT ON STAKEHOLDER(S)	As a water intensive industry, alcohol production poses risks such as water stress or depletion of local water sources if water use is not appropriately managed. In the case of Ramborn SA, the company has taken a circular approach to the design of its entire production system. The company only uses old standard meadow orchard trees which do not require irrigation or pesticides. Additonally, all of the water supply used to clean the fruits that are pressed to make its products is sourced by the local municipality. Waste water is non-toxic and is returned to the system.

IMPLEMENTED MGT PRACTICES	Ramborn SA uses only standard orchard trees (non-industrial farming), which means no irrigation is needed for growing the fruits. No pesticides or chemicals used in maintaining the trees that produce the fruits for Ramborn cider means that the waste water from cleaning the fruits is non-toxic. Additionally, there is no use of concentrate, which is the standard for the cider industry and uses significantly more water.
OTHER MANAGEMENT COMMENTS	Ramborn monitors its annual water consumption for each step of the production process. Compared to other alcoholic beverages like beer, very little water is required to produce cider. Additionally, the Ramborn approach is circular by design. As a result, the amount of water required to produce one liter of cider requires a little more than one liter of water.
