Disclosure Materials

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

B Lab's Public Complaints Process

Any party may submit a complaint about a current B Corp through B Lab's Public Complaint Process. Grounds for complaint include:

- Intentional misrepresentation of practices, policies, and/or claimed outcomes during the company's certification process
- Breaches of the B Corp Community's core values as expressed in our Declaration of Interdependence

Disclosure Questionnaire Category: Other - Disclosure Industries

Topic	Clients in Controversial Industries
Summary of Issue	Kiandra is a software company that helps optimize the performance of other companies. We provide custom software solutions to organisations to be able to manage their business. The company reported that in the last 5 years it has worked with clients in the alcohol, firearms and tobacco industry.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	In its 2022 fiscal year, Kiandra earned 5.46% of its annual revenue from the alcohol industry, 3.68% from the tobacco industry and 2.27% from the firearms industry.
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards
	will be created to address possible risks related to this matter.
Implemented Management Practices	The company has stopped providing services to clients in the firearms and tobacco industry. It is committed to not working with these industries in the future.
	Kianda does not have a formal policy in place to carry out due diligence of clients. It currently decides its clients on a case-by-case analysis, workers vote on whether or not a specific client should be accepted. The company shared that it is using B Lab's list of clients in controversial industries to identify industry's potential risks.
