

DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

TOPIC	Litigation and arbitration related to worker benefits/rights
SUMMARY OF ISSUE	48 cases of labor arbitration against the company were identified in the last 5 years, 27 cases are closed and 21 are still pending.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	The total historical amount paid (considering all cases) was less than 0.05% of company's revenue.
IMPACT ON STAKEHOLDERS	These lawsuits allege that company employees faced overtime and physical effects of the high demand for work required and were required to perform more tasks than they were hired to perform. There were also various claims for moral damages for unfair dismissal without of prior notice.
IMPLEMENTED MGT PRACTICES	"The company has provided guidance to managers in the company and with the labor team and has implemented training with managers to avoid new labor claims. Furthermore, it is maintaining a culture of feedback between the operational areas and managers to define and mitigate risks. The company also increased the recurrence of alignments with the legal team and the Personnel Department, to provide greater guidance and training to the team, making it more transparent for employees about their rights, and thus avoiding possible future issues."
RESOLUTION	From the total of 48 cases, 21 are still pending. Of the 27 closed cases from the last 5 years, 77% (21) of the cases were settled by agreement, which has already been settled between the parties. In 2 cases there was an unfavorable judgment against the company. 2 cases were judged favorable to the company and 2 case wer withdrawn.
RELATED INCIDENTS (YES/NO)	All the 48 cases are related.
