Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

B Lab's Public Complaints Process

Any party may submit a complaint about a current B Corp through B Lab's Public Complaint Process. Grounds for complaint include:

- Intentional misrepresentation of practices, policies, and/or claimed outcomes during the company's certification process
- 2) Breaches of the B Corp Community's core values as expressed in our Declaration of Interdependence

Торіс	Labor Issues
Summary of Issue	In March 2023 a member of The Keyholding Company (TKC) senior management was accused of sexual harassment by another employee. In response to the claim, TKC immediately suspended the accused employee pending the company's investigation. The investigation, including irrefutable CCTV evidence, resulted in the confirmation of the sexual harassment claim therefore the manager's contract was terminated.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	2 employees were directly impacted by the harassment. In response to the allegations, 18 employees voluntarily left the company in solidarity with the manager who was fired representing 9.68% of the workforce at the time. The new management then found the previous manager had also covered up poor performance in that team which led to an additional 17 employees being terminated from that team for poor working practices (9.14% of the company's workforce).
Impact on Stakeholders	Experiencing sexual harassment in the workplace can lead to mental health issues, burnout and/or post-traumatic stress disorder.
Implemented Management Practices	In response to the incident, the company provided support to the two affected employees through their Employment Assistance program which included counseling. In addition, the company implemented and/or reinforced the following policies: Non-Harassment Policy Micro-agression Policy
Management Comments	New management was put in place which needed to happen due to the seriousness of the issues. The voluntary departures occurred because they did not believe the allegations and for reasons of confidentiality, the evidence could not be shared with them.
	TKC was disappointed that people chose to resign in solidarity with the manager and that TKC then found poor practice in the



team. However, the change in leadership has enabled TKC to instill a new, positive culture in the Team with improved performance and standards.
