Topic	Complaints and penalties regarding consumer protection issues
Summary of Issue	Grupo Gire has received complaints from the consumer protection agency in Argentina ("Defensa del Consumidor") related to conciliation issues in company's systems that had generated financial impacts to clients/users and reported a cyber incident (malware was detected in the company's internal network, mainly affecting a system that Gire Soluciones uses to provide certain services to financial entities), which the company confirmed not to be related to data breaches.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	<p>The complaints, settlements, and fines, in 2022 and 2023, amount to ARG 23,620,538.00, representing 0.07% of the company's revenues.</p> <p>The company has an average of 35 monthly hearings and they estimate to receive annually 420 complaints filled by their consumers in the Argentinian Consumer Agency.</p>
Impact on Stakeholders	Having breaches of consumer protection regulations negatively affects customers' satisfaction and may cause financial impacts on them.
Resolution	Regarding conciliation issues, the company claims that people affected are users who made a payment at one of their branches and that payment for some reason was not made. Generally Grupo Gire manages to reconcile and, if appropriate, the company refunds the money to the user. The sanctions (fines) that company had are due to those cases in which they were unable to reach an agreement. In regards to the malware episodes, to the company's knowledge, agreements were closed: One of approximately ARG 510,000 pesos (Gire was in charge of reimbursing some expenses, originated by the failure to allocate the payments of the users of a company) and another of approximately ARG 21,500,000 pesos (Gire agreed to subsidize this Compensation to a company that was affected by the lack of Gire Soluciones services). Grupo Gire also claims to have paid approximately ARG 640,000 pesos in penalties for another company. Regarding claims from individual customers:

	Total claims received to date (06-26-23): 118 cases, of these, 59 cases are closed.
Management Practices	In general, if a company detects claims for the same issue, they evaluate whether the problem is due to a failure of the system, of our client companies or of the Agents. Once analysis has been carried out and the client's complaint has been solved, the company raises the issue to the responsible area in order to make the necessary corrections. The lessons learned from the cyber incident were reviewed and from it, together with Deloitte, a cybersecurity program was established that is being managed in order to optimize cybersecurity processes. A new CISO was hired to continue with the cybersecurity plan (short term) and work is being done on a new strategic cybersecurity plan for the medium and long term.
