



DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

TOPIC	Recalls
SUMMARY OF ISSUE	Recalls due to beverages leaking from their cans, likely due to sodium chloride (from salt) in the company's cocktail recipe at the time.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	Apologue LLC has had 1% (in revenue) or 30,000 USD in recalls from 2018-2022 a leaking issue with its canned cocktails, likely due to sodium chloride (from salt) in the company's recipe. The leakages happened only once. Cocktails started to leak, likely due to sodium chloride (from salt) in its formula.
IMPACT ON STAKEHOLDERS	The recalls were due to sticky cans. This did not pose a risk of illness or injuries to customers.
RESOLUTION	Disclosure Required
IMPLEMENTED MGT PRACTICES	The company removed the salt from the recipe and has not had an issue since, the company only buys certain cans with the best liners and no longer uses salt in its formulas.
MANAGEMENT COMMENTS	Can leaks can be caused from >15 different types of issues from can liner failure, high levels of dissolved oxygen, pH levels, seam application issues, and material handling problems, among others. It is common in beverages and Apologue has taken multiple steps to mitigate this risk going forward.
