



DISCLOSURE MATERIALS

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

TOPIC	Significant layoffs due to effects of COVID-19 pandemic
SUMMARY OF ISSUE	Fairware Promotional Products had one significant layoff in the last 5 years, and this occurred in 2020 as a result of the Covid-19 pandemic which has had a severe impact on its industry.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	<p>8 employees were laid off at the end of March 2020, from a total of 18 which equated to 44.4% of the workforce.</p> <p>By July 2020, the company was able to re-hire 4 of these employees, this means that 50% of the layoffs were permanent and 50% of the layoffs were temporary</p>
IMPACT ON STAKEHOLDERS	Primary impact was loss of employment for affected employees.
IMPLEMENTED MGT PRACTICES	<p>Employees were given the option of choosing a temporary or permanent layoff. Employees who chose a temporary layoff would still receive benefits for three months and then receive their severance at the end of the period (if they were not rehired). Employees who chose permanent layoffs would receive severance immediately and were also told that this choice would in no way impact the possibility of a rehire. This option was extended to give employees flexibility around severance pay and benefits.</p> <p>In addition to this, Fairware provided advice and support regarding available government programs for laid off employees, and assisted with navigating available programs. The company also provided access to available mental health services which some employees utilized. Where applicable, the company also made accommodations for employees on temporary work visas to ensure they would be able to fulfill visa requirements.</p>
