Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

TOPIC	Company has their waste sorting facilities located 50 meters away from the Rhône River
SUMMARY OF ISSUE	The Rhône River is a sensitive marine environment of historical importance to Switzerland's and France's river network and of ecological importance for its support of water plant species.
	The different infrastructures on the Rhone have favoured the development of intensive agriculture, roads, and industrial zones. However, these often pollutant activities have a considerable impact on the river.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	100% of the company's waste sorting facilities are located close to the Rhône River
IMPACT ON STAKEHOLDERS	Potential risks from operations located in sensitive ecosystems include damage to local environments from human and mechanical impacts, as well as indirect impacts from land conversion use and risks to flora and fauna.
IMPLEMENTED MGT PRACTICES	In order to sort waste on the territory they land, the company has formal authorization from the government of Geneva which involves several checks. This includes an issued regulation by the State of Geneva that the company must abide by, with the State of Geneva periodically carrying out checks. This may include placing retention trays under special waste containers, training personnel in case of chemical spills, carrying out regular drills, and equipping vehicles with appropriate equipment such as absorbent liquids or plugging drains. Groupe Serbeco is also certified in ISO 14001 which allows them to guarantee environmental risk management.

SUMMARY OF ISSUE	As a company that collects and sorts waste, Groupe Serbeco operates in an industry in which energy use and emissions are material environmental issues.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	In the previous fiscal year, 77% of the group's revenue was earned from waste management services.
IMPACT ON STAKEHOLDERS	The waste collection and management process is energy intensive, which in turn contributes to global carbon emissions. The process mainly requires electricity to move the sorting machinery and fuel for transport. The main GHG emitted in the process is CO2. 77% of the groups energy consumption comes from fuel consumption (with 91.7% is diesel and 8.3% is biodiesel). The remaining 23% corresponds to electricity consumption The scope 1,2 carbon intensity of the group is 22.2 kg CO2e / ton of waste managed in 2021
IMPLEMENTED MGT PRACTICES	Groupe Serbeco has an ISO14001 certified environmental management system and is tracking their waste generation, water use, energy use, and GHG emissions. In order to reduce the environmental impact of their operations, the company has installed solar panels (that cover 1.6% of their total energy demands) and 20% of their fleet is electric The company has a target to be CO2 neutral by 2030
