TOPIC	The Company is a designer and manufacturer of wood furniture
SUMMARY OF ISSUE	Fishtnk is a designer and manufacturer of wood furniture, with the vast majority of their revenue comes from selling wood products.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	96% of their revenue comes from selling wood products.
IMPACT ON STAKEHOLDERS	The production and manufacture of wood products may involve deforestation, leading to loss of habitats and carbon sinks.
IMPLEMENTED MGT PRACTICES	The Company has intentionally chosen wood species that cannot be clear-cut, and come from locally managed woodlots and forests that practice selection harvesting. They use 2 local lumber mills that are both under 50km from their production facility. This is characteristic of the species they choose to offer their products in makes all the difference for types of woods and species selection harvesting is not an option, they only purchase FSC-certified lumber from local, certified companies with a reputation for good practice in the industry. The Company declares that sustainability is an intertwined process that is not about one specific decision but about a mindset and way of thinking and operating. By conserving energy, they reduce their greenhouse gas emissions, by reducing plastic use, they reduce pollution by designing products that use clear-cut wood and nurture better forests, and all these small but impactful decisions will contribute to preserving and conserving biodiversity in all areas that their supply chain reaches. The company has taken decisive steps to only use domestic hardwood, local sources, and grown lumber from FSC-certified suppliers to make sure the products are not contributing to deforestation and loss of wildlife habitat. The Company does not work with exotic woods or imported wood from vulnerable regions to specifically address this issue. Based on the types of wood they use, and the fact that they are harvested with the "Selection Harvesting" practice, which manages woodlots more sustainably and allows healthy replacement of mature trees (not old-growth) with younger and more diverse trees which should equalize and be carbon neutral. Also using wood for long-term use acts as carbon storage vs. decaying wood from dying or dead trees that produce CO2.

SUMMARY OF ISSUE	As a wood furniture manufacturer, the industry is energy and emissions-intensive. However, the company uses high-efficiency equipment for production all run only on renewably sourced electricity. Due to the scale of operation and type of production, they are an energy-smart operation. The company's highest dependency on energy is for heating the space during winter months and we have significantly reduced its impact by using smart thermostats and sensors.

IMPACT ON STAKEHOLDER(S)	The manufacturing industry is a major contributor to global emissions.
IMPLEMENTED MGT PRACTICES	Fishtnk Inc buys its energy, electrical, and gas from Bullfrog power, they offer the highest-quality renewable energy certificates (RECs) to help customers maximize their carbon reductions and transform their energy systems. The Company source exclusively from projects that meet or exceed the strictest environmental criteria, as defined by EcoLogo®. The Company supports the development of new wind, solar, and low-impact hydro projects by purchasing from EcoLogo new sources. promote renewables across Canada, including in carbon-intensive grids, by sourcing 50% of RECs from the region. Green natural gas: green natural gas is sourced from organic waste at landfills or wastewater treatment plants. green natural gas meets strict environmental standards set by ICF International. For more general information customers can also visit the sustainability page on their product's website: https://www.aaline.ca/sustainability-aaline The company tracks its carbon intensity per unit product. As an example: the LW-EB series at 8-foot length, the company estimates has 9.5 KgCO2. The same system made with imported aluminum extrusions has 28.7 KgCO2. They are working with the Declare Label to have a much more transparent labeling system for their products and keep a database of their collection on the 2030 Calculator platform.
