Disclosure Questionnaire Statement

Disclosure Questionnaire Category: Other - Clients in Controversial Industries

Topic	Clients in Controversial Industries
Summary of Issue	Studio Graphene Limited is a customer software development studio that plans designs and builds digital products in partnership with companies. Over the last 5 years, the company has served clients in the Alcohol and Gambling industries. Services to the company in the gambling industry involved the creation of a free-to play game and services to the client in the alcohol industry was in relation to website support. Services offered can be sold to both client in controversial as well as non-controversial industries.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	In FY2022, clients operating in the Alcohol industry represented 0.1% of revenue and clients in the Gambling industry represented 1%. The company no longer works with clients operating in the Alcohol industry.
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemented Management Practices	Studio Graphene has multiple filters when evaluating clients that could potentially be considered to operate in a sensitive industry. Client selection depends on: - Whether the team wishes to work with the client and if someone does not wish to, then work is not taken up with this client. - Whether the work that they will carry out has a potential negative impact on society (self assessed); - Whether the company operates in an industry that they consider has a negative impact on society and whom the company has a position not to work with, eg company will not accept work for companies that trade arms and ammunition.

	The company has a strong position to not work with Cannabis-Related Products, Casino Industry Companies, Charity Lotteries , Debt Collection Agencies in Emerging Markets, Engineering Consulting Companies with Clients in the Defense Sector, Fossil Fuels & Energy Companies, Mining Industry and Serving Governments tied to Human Rights Violations. In addition, the company recognizes that Banking in Switzerland, Pharmaceutical companies, Bottled water companies and Energy companies can be considered controversial industries and choose to evaluate each individual company in their practices, ethics and standards before considering working with them.
Management Comments	No new clients in controversial industries were added to the company's client portfolio since December 2022.
