

DISCLOSURE MATERIALS

- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

SUMMARY OF ISSUE	A Beautiful Story B.V. sells jewelry plated in precious metals and containing gemstones. Precious metals and gemstone material supply chains are generally recognized as posing a human rights risk. A Beautiful Story B.V sources products from suppliers in Nepal and India.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	Approximately 88.85% of the turnover of products sold by A Beautiful Story B.V. are jewelries.
IMPACT ON STAKEHOLDERS	The use of precious metals and gemstones poses a human rights risk due to the possibility that they are sourced from conflict-affected and high risk areas, where they may be used to finance conflict and/or be associated with human rights abuses in the supply chain. Specifically, the mining sector has a high potential for human rights abuses given the elevated risks of fatal accidents, abusive labor practices, discrimination against women and environmental pollution and degradation.
IMPLEMENTED MGT PRACTICES	"A Beautiful Story B.V. created a Social Compliance system to guide them in decision-making and assess their supply chain impact. The system is focused on compliant supply chain and impact driven collaborations, and all their suppliers are scored according to their practices. Every year, suppliers are required to share certifications or updated audit information, and sourcing and wages policies. From that, the company is able to map what are the main risks in their supply chain and points of improvement to work closely with their suppliers. Currently, the company claims that 68% of their products are totally traceable. A Beautiful Story B.V. is working with suppliers to increase the visibility in their supply chain. The company is currently developing a Pilot of Retraced, which is a system in which suppliers will be required to fill in all sourcing data, improving the transparency regarding the materials used in the production of their products.
