TOPIC	Biodiversity Impact and Monoculture Agriculture
SUMMARY OF ISSUE	As a coffee farm, Daterra Atividades Rurais operates in an industry in which biodiversity impact and monoculture agriculture are material environmental issues.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	100% of Daterra Atividades Rurais' revenue is from coffee sales. The company controls 6,700 hectares of land, of which a maximum of 2,800 hectares are cultivated annually. The uncultivated land is comprised of native forests, regenerative area, wind breakers, and plantation corridors.
IMPACT ON STAKEHOLDER(S)	Agriculture, particularly in cases where a single crop is cultivated at a time, poses a risk to local ecosystems of flora and fauna as well as the potential degradation of cultivated land.
IMPLEMENTED MGT PRACTICES	Daterra Atividades Rurais uses several practices to manage its impact on biodiversity and soil health. The company builds biological corridors to allow fauna to move freely on their land, and plants native species of trees around the land to facilitate a cooler temperature. The company also utilizes composting and plants other crops in-between lines of coffee, such as beans and grass, to help organically manage soil health. The company only uses chemicals that are approved by the Rainforest Alliance, and aims to strike a balance between chemical and biological management practices. To that end, Daterra Atividades Rurais has a research area of 230 hectares dedicated to experimenting with organic composting and biomass techniques in order to find the optimum balance between chemical and biological practices.

TOPIC	Water Intensive Industries
SUMMARY OF ISSUE	As a coffee farm, Daterra Atividades Rurais operates in an industry that is water intensive.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	100% of Daterra Atividades Rurais' revenue is from coffee sales. 43% of the company's land is irrigated (25% of irrigation is drip, and 74% is pivot irrigation).
IMPACT ON STAKEHOLDER(S)	As a water intensive industry, coffee farming poses risks such as water stress or depletion of local water sources if water use is not appropriately managed. All of the water used by the company is sourced from water sources on the company's land: water springs, rainwater, and dams built in partnership with its neighbors.
IMPLEMENTED MGT PRACTICES	Daterra Atividades Rurais manages its water use by using pivot and drip irrigation, and salvaged water. For example, water used in its processing facilities for sorting coffee beans becomes nutrient-rich as a result of this process, and is then added to the company's composting process that is then used to nurture the soil. In addition, the company preserves more than 20% of the land around its water sources (which is the minimum regulatory requirement). Regarding the use of dams, environmental impact of such dams and the long-term impact on the water source and nearby stakeholders is assessed by both government regulatory agencies as well as Rainforest Alliance certification.

TOPIC	Litigation relating to employee injuries
SUMMARY OF ISSUE	In the past five years, four lawsuits have been filed against Daterra regarding injuries sustained by employees. Three of which regard injuries that resulted in indirect termination, as the employee was no longer able to perform their job responsibilities.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	The lawsuits involved 4 employees out of a current workforce size of ~770 employees. One lawsuit resulted in the payment of R\$ 40,290.40 by Daterra, and the remaining 3 active cases have a cumulative claims value of R\$ 161,059.
IMPACT ON STAKEHOLDER(S)	The lawsuits make claims for various forms of financial compensation related to injuries that occurred on the job site. The injuries sustained were two fractured fingers, one back injury, and one loss of vision.
RESOLUTION	Daterra was ordered to pay damages in one case. The other three cases are pending.
IMPLEMENTED MGT PRACTICES	Daterra offers training on safety as well as health that starts during the entrance of the employee and reinforced every 6 months. Protective equipments are given everyday and employees must sign and register to make sure it is with them. When an employee is prevented to keep working, the company reaches an agreement that includes paying continuous health support like physical therapy, in accordance with local law.
RELATED INCIDENTS	Four related cases of litigation described here.
