This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

SUMMARY OF ISSUE	Miraplast is a Brazilian based product packaging provider specializing in the production of recycled post consumer flexible packaging for bagging aggregates (sand, stones and derivatives), mortars, agribusiness and landscaping, polymers, e-commerce and others.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	100% of the raw materials used for producing manufacturing products are made from recycled post consumer plastics.
	65% of revenue is from the sale of flexible packaging and 35% from services provided in waste management for client companies.
IMPACT ON STAKEHOLDERS	Product packaging is a material environmental issue. Packaging life-cycle and waste management practices are an important consideration to mitigate impact caused by this industry. B Lab has flagged the single use plastics industry as an industry that would require additional risk standards in the future.
IMPLEMENTED MANAGEMENT PRACTICES	The company uses zero virgin plastic in its manufacturing process. The packages produced are classified as LDPE - Low-density polyethylene, that is, 100% recyclable. Miraplast has obtained the Senaplas seal, a recognized certification for plastic recycling companies. This certification validates Miraplast's adherence to socio-environmental and economic criteria required by law. The company is committed to responsibly sourcing and certifying their recycled input materials, ensuring compliance with rigorous standards. As a Recycling Operator in the reverse logistics chain, Miraplast provides packaging to brand owners. Miraplast also engages in collaborative efforts with their waste management service customers to promote recycling practices and facilities in the markets they operate in. By working closely with these partners, Miraplast leverages their customers' post-consumer recycled (PCR) plastic waste to produce packaging materials like e-commerce envelopes.
