Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Disclosure Questionnaire Category: Others - Clients in Controversial Industries

Topic	Clients in Controversial Industries
Summary of Issue	Resident Advisor (RA) runs a platform where people can discover music, artists and events. The company provides ticket sales, brand and festival partnerships and advertising services for clients in the entertainment field. This service is also provided to clients in the Alcohol industry. In collaboration with the client, RA promoted a campaign called SaveTheNight which aims to find people all over the world with innovative ideas for improving the nightlife landscape and grant them the necessary funding to bring them to life.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	At 2022, 1.1% of the company's annual revenue was derived from clients in the alcohol industry
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry.
	B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemented Management Practices	RA screens projects and clients' corporate social responsibility to ensure it fits their values and overall objective which is to make a positive impact in the electronic music community.
	RA partners up with clients in sensitive industries if their code of ethics aligns with their own code of ethics.
	All potential brand partnerships are assessed by RA's high level executives and C-Suite which includes the Chief Executive Officer, Chief Creative & Brand Officer and Chief Impact & Culture Officer. Before any brand partnership is confirmed, RA



will evaluate the community benefit that the partnership will provide such as the community beyond RA, be it promoters, artists etc, benefits from finance, exposure and support that clients wouldn't have had access to if RA weren't working with the brand.
