

DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

SUMMARY OF ISSUE	ViRTUS is a Canadian leadership development and strategic planning company. The company provides leadership development, executive team development, and/or coaching programs for clients from the gambling and fossil fuel industries.
	The services offered to the gambling client are leadership development, coaching, and executive team development programs, at the director and executive team level.
	For the client in fossil fuels, the company offers programs for the client's management team, focussing on leadership development and coaching.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	In the 2021 fiscal year, 6% of the company's revenue was represented by clients in the gambling industry and 13.3% of revenue was represented by clients in the fossil fuel industry.
IMPACT ON STAKEHOLDERS	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry.
	B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
MANAGEMENT PRACTICES	To avoid working with companies in controversial industries in the future, the ViRTUS business development team utilizes B Lab's list of DQ industries to scope client fit. Values alignment is taken into consideration during the evaluation of prospective clients. The company has declined work from companies and industries that do not share the same values of the company and the B Corp Certification (e.g. declined work from the tobacco and fast food industries).
	Within the gambling industry, the company chose to work with a client which is highly regulated under British Colombia's government, and reinvests revenue from gambling operations into key services for the province. The company also has an internal commitment to not work with forprofit private gambling entities in the future.
	In relation to clients in the fossil fuel industry, the client selected was recognized as one of Canada's top 100 employers for 2023.
