Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

SUMMARY OF ISSUE	Natural Paint UK is a manufacturer of natural plant based paints thus producing sustainable paint products as well as being transparent regarding the ingredients used to make its products.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	94% of the company's revenue is derived from the sale of Natural paint products.
IMPACT ON STAKEHOLDERS	As a chemical-intensive industry, the production of paint has significant impacts on the environment, such as pollution of air, land, and water, as well as potential human health risks to those exposed to the harmful chemicals that are used to make modern acrylic paint. The use and disposal of these chemicals are not properly managed or regulated.
IMPLEMENTED MGT PRACTICES	 Natural Paint UK has compared itself to other companies in the industry that have made their ingredients transparent. The company's paints differ from other companies in the industry due to the implementation of the following practices: The replacement of commonly used acrylic, so fossil fuel based binders with plant-based binders made with maize and wheat as the feedstock plus a naturally occurring plant ammonia. Avoiding the addition of microbeads or nano particles known to be a dangerous pollutant if ingested by aquatic organisms and passed back up the food chain to humans. All ingredients used to produce natural paints are considered compostable. Natural Paint UK avoid the use of Perfluoroalkoxy alkanes or PFA's used typically used by others in the industry to enhance scrubability and make paints waterproof or stain resistant. Different from the water and energy intensive petro-chemical supply chain Natural Paint products are made in a closed plant that recirculates grey water for low level washing and water that is discharged is done so under a local authority permit and constantly monitored as safe to be discharged. Water at the colour mixing facility in Herefordshire is only used for washing and is put through anaerobic digestion sufficient to be discharged to a soakaway on the site. The company conducts an annual Impact Report and has launched a 'Lifting the Lid' campaign to give people the truth about the polluting paint industry, with 3rd party scientific references and data from industry experts.
