

DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

горіс	Viridis Terra derives a part of their revenue from operations based in conflict affected areas of Haiti and Burkina Faso.
SUMMARY OF ISSUE	Viridis Terra provides consultancy on restoration and reforestation activities on degraded lands. They help their clients to turn degraded lands into productive land for future use of natural resources. Their clients are governments, industrial companies, public and private agricultural landholders. They currently have two ongoing projects in Burkina Faso and they worked on one project in Haiti in 2021.
	Both countries are in the 2022 list of fragile and conflict-affected countries created by the World Bank Group.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	The company derived 8% of its revenue from projects in conflict affected areas in 2021.
IMPACT ON STAKEHOLDERS	As per the OECD, conflict zones are often characterized by widespread human rights abuses and violations of national or international law.
	The security of company workers who work in such areas could also be at risk.
IMPLEMENTED MGT PRACTICES	Viridis Terra claims that in all their operations based in Haiti and Burkina Faso they are in constant monitoring mode. They use in-house experts and local partners' expertise to asses the situation on the ground. In addition to that, they use information collected from personal and professional contacts, and from external sources to conduct triangularization of data.
	Through the use of strong ties with well-established local organizations, Viridis Terra systematicly uses of their partner's expertise and experience for planning or implementation purposes, including conflict prevention and mitigation approaches.
	The company claims to respect the highest possible standards with regards to human rights, Integrated Social Responsibility, and other internationally recognised standards such as ILO 169 and IFC/PS.
	Viridis Terra has a code of conduct related to their commitments to fight against corruption and sexual abuses. They have a gender policy, a whistle blower policy and an overarching human rights policy. The company also works with associations and/or organizations that have a proven ability to prevent and resolve conflicts.
