This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

TOPIC	Significant layoffs due to the impact of COVID-19 and 95% contraction in the business
SUMMARY OF ISSUE	In March 2020, staff were put on notice due to the immediate impact of Covid-19. March - September 2020, staff were let go dependent on their personal circumstances (eg returned to New Zealand) or notice period. There have been no other layoffs in the past 5 years.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	10 employees were laid off, representing 83% of the company's employees at that time.
IMPACT ON STAKEHOLDERS	Primary impact was loss of employment for affected employees.
IMPLEMENTED MGT PRACTICES	The company retained staff beyond their normal notice periods due to the Governments Furlough scheme which enabled the company to part pay staff & be topped up by the Government.
