Summary of Issue	<p>TemperPack is a sustainable packaging company that designs and manufactures high-performance thermal and protective packaging solutions. The company focus on replacing traditional plastic foams (like Styrofoam/EPS) with recyclable, compostable or plant-based materials such as their patented ClimaCell liners and Green Cell Foam.</p> <p>Over the reporting period (Last five years), TemperPack Technologies Inc. addressed a number of litigation matters and regulatory penalties. These matters primarily relate to:</p> <ul style="list-style-type: none">(i) One intellectual property dispute.(ii) workers' compensation claims.(iii) a motor vehicle accident involving an employee, and third party.(iv) OSHA workplace safety citations at specific facilities. <p>All these matters were resolved through appropriate legal processes, including settlements, court decisions, or are currently under formal appeal in accordance with applicable laws.</p>
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	Resolution of all matters represented on average less than 1% of annual revenue over the span of the payment periods.
Impact on Stakeholder(s)	The matters primarily impacted employees through workers' compensation claims and workplace safety–related OSHA citations, as well as third parties in connection with an intellectual property dispute and a motor vehicle accident involving a company vehicle. The impacts were case-specific. All identified risks were addressed through remediation, settlements, or corrective safety measures.
Resolution	<p>The intellectual property matter was resolved and closed pursuant to a confidential settlement agreement.</p> <p>Workers' compensation matters were settled with payment,</p>



	<p>closed and pending. The motor vehicle accident claim remains pending, with the company actively defending the matter. OSHA citations issued between 2023–2025 were paid in full, and all cited conditions were fully abated at the time of inspection.</p>
Implemented Management Practices	<p>To the case related to the Intellectual Property, the company asserts a stance on non-infringement and embeds this principle into its operations by actively ensuring respect for third-party rights.</p> <p>In terms of employee and public safety, the company implements preventive controls, including rigorous background and driving record checks for employees operating vehicles. This reflects a proactive approach to mitigating operational risks before incidents occur.</p> <p>Workplace health and safety management is supported by formalized programs and continuous monitoring. The company maintains a hearing conservation program with regular audiometric testing for employees exposed to elevated noise levels, ensuring ongoing compliance with occupational health standards. Routine safety inspections, such as documented weekly safety walks by management, further reinforce hazard identification and mitigation.</p> <p>Additionally, the company adopts corrective and preventive measures in response to identified risks. These include upgrading equipment with safety features (e.g., interlock systems and machine guarding), implementing lockout-tagout (LOTO) procedures, and establishing standardized operating procedures (SOPs) and dress codes. These actions indicate a systematic effort to both remediate hazards and prevent recurrence.</p>
