Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Topic	Clients in Controversial Industries
Summary of Issue	Idoya is a business consultancy that has had a client operating in the Fossil fuel (Coal, oil sands) industry on an on-going basis over the last 5 years. The nature of the company's service was in relation to energy diversification and sustainable development for the client's industrial site; from strategy to design and including support in the team's adaptation to new low-carbon activities. Although Idoya's service is adapted to their client's needs, their service can be sold to companies in both controversial as well as non-controversial industries.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	Idoya has worked with the client operating in the fossil fuel industry 3 times over the last 5 years, representing 19% of their FY2022 revenue.
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemented Management Practices	Idoya has an exclusion policy in place for evaluating potential work with clients in controversial industries which the company has based on B Lab's list of controversial industries as well as SRI sectoral and normative SRI exclusion lists. The evaluation process involves an analysis of whether the particular project mission contributes to reducing or developing the negative aspects of the controversial industry including: -The evaluation of the client's intentions -Their contribution towards sustainable development -Whether the work adds value -Whether the work's social and environmental contributions are measurable.
