Topic	Clients in Controversial Industries
Summary of Issue	Firma is a company specialized in providing brand strategic consulting services. The company has had clients from controversial industries such as Alcohol and Pharmaceuticals. All of the company's services can be sold to both controversial as well as non-controversial industries,though the company's services is tailored to specific client needs.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	In the fiscal year of 2023, an estimated total of 8.37% of revenue were generated through the clients in the alcohol industry, and 2.78% of revenue were generated through clients in the pharmaceutical industry.
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry.
	B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemented Management Practices	The company has declined to work with companies that are involved with fossil-fuels in the past. As of 2024, the company has decided not to collaborate with clients included in controversial categories such as Gambling, firearms, weapons, munitions, pornography, tobacco, recreational marijuana, prisons, fossil fuels – coal mining, oil sands and nuclear power. Although Firma does not have a formal policy in place currently,
	the company is committed to supporting clients who are committed to sustainability, social responsibility, and ethical practices.
	This client selection criteria is integrated into the company's decision to pursue business or decline a business relationship



to ensure that the partnership reflects Firma's mission and standards which emphasizes the Environment Social & Governance (ESG) values. The company is in the process of developing a defined policy accessible to the entire team to ensure compliance in its client screening processes.
