



DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

TOPIC	Clients in Controversial Industries
SUMMARY OF ISSUE	Dig Agency is an advertising services provider, providing customers with a communications strategy and execution service. The company has had a client operating in the alcohol industry on an ongoing basis. The company's service is aimed at both clients in controversial industries and non-controversial industries.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	12% of the company's revenue in the last fiscal year was from clients operating in the alcohol industry, represented by 1 client.
IMPACT ON STAKEHOLDERS	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
IMPLEMENTED MGT PRACTICES	Retailing of alcohol in Australia is heavily regulated in terms so that advertisements cannot target certain audiences or contain specific messages. Every business looking to advertise alcohol in Australia must abide by the Alcoholic Beverages Advertising Code (ABAC). The code is a development of the Alcoholic Beverages Advertising Code Scheme, which sets the requirements for alcoholic advertising in Australia. The company follows the ABAC Code when working with alcohol retailers. When working with an alcohol retailer we follow the ABAC code. The company has a position explicitly stating that it will not work clients from the tobacco or firearms industries.
