SUMMARY OF ISSUE	As a vineyard and winery,Viña Polkura SA operates in an industry in which biodiversity impact and monoculture agriculture are material environmental issues.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	In the previous fiscal year,100% of Viña Polkura SA's revenue was earned from the sale of wine 30% of the land under the company's control is cultivated as a vineyard, and 70% is uncultivated. Approximately 100% of cultivated land is planted or re-planted each year. The uncultivated land has agriculture potential where approx. 25% is designated for conservation and reforestation
IMPACT ON STAKEHOLDERS	Agriculture, particularly in cases where a single crop is cultivated at a time, poses a risk to local ecosystems of flora and fauna as well as the potential degradation of cultivated land.
IMPLEMENTED MGT PRACTICES	The company keeps the natural grass of the area and does not till the soil on most of the surface. The doses used for pesticides and fertilizers are the minimum required. The company use organic and traditional pesticides and fertilizers; for its application use drones, to reduce the carbon footprint and exposure of the operators.
MANAGEMENT COMMENTS	The company has finished a biodiversity inventory with the Universidad Austral de Chile.

Water Intensive Industries
As a vineyard and winery, Viña Polkura SA operates in an industry that is water intensive. Aspects of the industry that make it water intensive include irrigation used in the cultivation of vines, water used in the winemaking process (e.g. for cleaning tanks and barrels), and water used in the bottling process.
In the previous fiscal year, 100% of Viña Polkura SA's revenue was earned from the sale of wine 100% of the company's vineyards are irrigated with technical irrigation, drip irrigation. The company is implementing the Root Drying Technique to save in approx 30% to 40% of water usage. In part of the company's vineyards, only rainwater is used. Compared with the industry, the company uses approx. half of the water usage compared with traditional vineyards
As water intensive industries, agriculture and wine production poses risks such as water stress or depletion of local water sources if water use is not appropriately managed.
The company measure their water usage. In order to reduce water usage, the company has started to use rainwater. According to the weather conditions, the company remove productive hectares and others are put into dormancy to reduce water stress.
The company with the University Catolica de Chile carried out a study to determine its footprint. The company with local vineyards has started a collective project to measure the water footprint together; the project is in the evaluation phase.
