



DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

TOPIC	Clients in Controversial Industries
SUMMARY OF ISSUE	Yard Associates provides website data services to companies operating in the fossil fuel industry and the gambling industry on an ongoing basis. The company collects and surfaces data as well as supports on reporting and analysing data related to customer behaviours across their client's digital touchpoints using analytics tools. The service provided is not specifically designed to help companies manage the harm created by the controversial industry. Yard provides a standard service to companies in both controversial and non-controversial industries and charges both according to the same fee structure.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	Clients operating in the fossil fuel industry represented approximately 10.28% of Yard's 2021 turnover. Clients operating in the gambling industry represented approximately 12.68% of Yard's 2021 turnover.
IMPACT ON STAKEHOLDERS	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
IMPLEMENTED MGT PRACTICES	Yard does not currently have a position related to working with clients in controversial industries, yet has an internal non-exhaustive list of industries they would not work with such as firearms/ weapons manufacturing, short-term high interest lending, prisons, illegal products, industries at risk of human rights violations. Yard does not currently have policies and practices in place for carrying out due diligence of clients that they work with to ensure that their services are not used for harming people and the environment. However they are reviewing their processes.

MANAGEMENT COMMENTS	Yard does not preclude itself from working with responsible and ethical businesses simply because they are part of a controversial industry sector. However, they would consider very carefully before taking on clients from potentially sensitive industries. Client vetting, auditing and due diligence processes are under review to address this issue.
