DISCLOSURE QUESTIONNAIRE CATEGORY	Animal Products and Services
TOPIC	Kipster is a company which operates an animal farm and has direct control over the treatment of animals in its care.
SUMMARY OF ISSUE	The Kipster Farms are designed around the needs and instincts of the chicken. Kipster operates a cage-free system, with outdoor access, no beak trimming and no killing day-old roosters. Hens have access to a large indoor garden with natural daylight, tree stumps and branches, alfa and straw bales and pecking blocks. The company considers their birds waste processors, because they upcycle rest products from the (agricultural and food industry) into meat and eggs.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	During the last fiscal year 2021, 100% of Kipster's total revenues was from the sale of animal products. Throughout the year on average 63.388 animals were present at both farms combined. The stocking density is max 6.7 hens per m2.
IMPACT ON STAKEHOLDERS	The sale or use of animal products and animal-related services by businesses poses a risk to the humane treatment of animals if adequate management practices are not in place.
IMPLEMENTED MGT PRACTICES	 Kipster is Certified Humane in the US, and produces eggs and meat according to the 3 Star Better Life welfare label, PlanetProof. The company's practices go above and beyond these certifications and include: Hens are caught with the use of the Catching Method developed by Eyes on Animals to ensure less stress. They have designed an indoor playground with daylight, natural enrichment, and plenty of variation allowing them to anticipate bird flu and poor weather. The birds can range free in a gated outdoor playground, tailored to their needs and protected against predators. Feeding chickens a vegetarian diet (consdering they are omnivores). Cannibalism is mitigated by offering a varied environment, rather than debeaking birds. Day-old roosters are not sacrificed but are grown up for consumption. The company runs a transparent operation, making available 24/7 live cams connected to YouTube, for anybody to see what's going on in and around the farm and in addition, has a visitors center. Policymakers, journalists, scientists, and farmers from around the world come to see Kipster's approach to animal husbandry and food production. Has set targets/ KPIs on animal welfare. Some of them are published in their annual report (link below).

SUMMARY OF ISSUE	As a Chicken Farm, Kipster operates in an industry in which biodiversity impact is a material environmental issue.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	Approximately 100% of Kipster revenue comes directly from operating animal farms.
IMPACT ON STAKEHOLDERS	Animal agriculture poses a risk to local ecosystems of flora and fauna as well as the potential degradation of farmed land.
IMPLEMENTED MGT PRACTICES	Kipster does not currently monitor its impact on biodiversity. However, the company's up-cycle feed practices require less land and feed crop production, water, pesticides, fertilizer, carbon emissions, which the company expects to have a lower impact on biodiversity.

SUMMARY OF ISSUE	As a chicken farm, Kipster operates in an industry that is water intensive.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	Approximately 100% of Kipster revenue comes directly from operating animal farms.
IMPACT ON STAKEHOLDERS	As a water-intensive industry, animal agriculture poses risks such as water stress or depletion of local water sources if water use is not appropriately managed. Their feed supplier buys feed from all over the world. The yield, quality, and price of feed are highly dependent on climate and weather conditions. Kipster farms in the Netherlands are not situated in water-stressed regions. They are located in Oirlo (Limburg) and Beuningen (Gelderland). Kipster expects to experience more droughts in the Netherlands in the future and then there might be temporary bans on groundwater extraction in certain regions. They do not extract groundwater and only use tap water on their farms.
IMPLEMENTED MGT PRACTICES	The on-farm water use is monitored on a monthly basis. The company does not have any water use reduction targets or policies yet.

SUMMARY OF ISSUE	As an animal farm, Kipster operates in an industry in which energy and carbon emissions is a material environmental issue.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	Approximately 100% of Kipster revenue comes directly from operating animal farms.
IMPACT ON STAKEHOLDERS	Animal agriculture is a major contributor to global carbon emissions.
IMPLEMENTED MGT PRACTICES	GHG emissions and energy use are monitored on a monthly basis. Kipster produces its own solar energy and buys only green energy; delivering the surplus solar energy back to the grid. In addition, the company mainly uses up-cycled feed, lowering the eggs' carbon footprint by approximately 45% in comparison to using grey energy and a conventional laying hen feed in 2021. In 2021, Kipster also made a first attempt in setting a carbon budget for 2022. In 2022 this is being optimized by including targets for further reduction of their carbon footprint in 2023, such as looking for new up-cylced feed ingredients and optimizing on-farm energy efficiency. Kipster eggs produced in the United States are certified CarbonNeutral® (not including use).
