Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Summary of Issue	NSI Solution offers digital transformation and advisory services as well as software implementation services. The company has had clients operating in the Cannabis-related products (excluding recreational marijuana), the Fossil Fuel (excluding coal, oil sands) industry as well as provided services to Engineering companies that serve clients in the Defence Sector. The company's services can be sold to companies in both controversial as well as non-controversial companies.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	In FY2022: • 1.073% of the company's revenue was derived from the Cannabis-related products industry. • Engineering companies attending the Defense industry represented 0.038% of the company's revenue. The company no longer works with companies that serve the Defense industry. • Clients operating in the Fossil Fuel (excluding coal, oil sands) represented 0.049% of the company's revenue.
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemented Management Practices	NSI Solution has implemented a checklist for when their Sales team qualifies new clients to exclude any new assignments from controversial sectors. The company excludes work with companies operating in controversial industries. In addition, part of the company's project scope is understanding the client's vision/mission and services and if they agree with their values.
