- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

TOPIC	Labor litigation related to employment termination
SUMMARY OF ISSUE	In the past 5 years, Performance Lab Group had two cases of labor litigation that resulted in settlements in favor of former employees. Both cases regard to labor claims filed by former employees who were demanding unfair dismissal; both were settled in favor of the plaintiffs (former employees). In those cases, the company claimed that the dismissals were due to poor performance and personal conduct.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	Cumulatively, both claims amounted to £60,000 which equates to less than 1% of revenue.
IMPACT ON STAKEHOLDERS	Two former employees were affected by the cases.
RESOLUTION	The company paid a settlement in favor of plaintiffs, in 2022, in both cases.
IMPLEMENTED MGT PRACTICES	Performance Lab Group has recruited a new member of staff to oversee Human Resources and ensure staff wellbeing is a top priority. The new HR employee is now responsible for implementing an all-business/team structure, processes, and policies to set grounds on behavior expectations, ways of working, and conflict management. A Performance Management process was implemented to ensure any performance and behavior issues can be addressed and supported accordingly.
