- Intentional misrepresentation of practices, policies, and/or claimed outcomes during the company's certification process
- Breaches of the B Corp Community's core values as expressed in our Declaration of Interdependence

Topic	Company serves clients in Controversial Industries
Summary of Issue	Wood Thilsted Ltd is a company specialized in offshore wind engineering consultancy.
	The company has had clients in the Fossil-Fuel industry (which also includes coal/oil sands). The services provided to the clients relate to the Design of Offshore Wind Farms.
	The nature of windfarms means that leases are awarded to specific companies/industries. Failure to support their development would slow down the pace of decarbonisation and have a negative impact on society.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	In the fiscal year of 2024, 8.09% of the client revenue has been from clients in the fossil-fuel (non-coal/oil-sands) industry and 0.55% of revenue were from clients who were involved in fossil fuel which includes coal/oil sands.
	The company has been providing its services to the clients from the fossil-fuel industry since 2022 and the company charges a flat rate to all of its clients regardless of the industry they are from.
Impact on Stakeholders	Companies that offer products/services to clients in controversial industries may be contributing to the controversial impact of those industries.
Implemented Management Practices	Wood Thilsted is committed to only working with energy/oil & gas companies that have commitment to decarbonize their energy mix. The company has a position to not provide any services to the current clients outside the support of their Offshore Wind assets.
