



DISCLOSURE MATERIALS

- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

SUMMARY OF ISSUE	Azimuthzero is a consulting company based in Chile that offers the service of searching for industrial suppliers for its clients as well as carry out supplier auditing, quality control and logistics management. The company has a standard service that it offers to all types of clients and the suppliers sought depend on each client's needs; they vary from physical product suppliers to service providers. Azimuthzero has clients in the mining & gas industries on an ongoing basis.

Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
IMPLEMENTED MGT PRACTICES	Azimuthzero has some initial screening policies to evaluate their clients before working with them. The company only works with clients that comply with all current legislation and exceed regulations by implementing ESG policies and programs. For clients with international presence, the company also investigates their global regulatory and legal compliance. The company checks their clients social and environmental certifications to verify what mechanisms they have in place to mitigate possible negative impacts.
