



DISCLOSURE MATERIALS

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

ISSUE DATE	March 2020
TOPIC	Significant layoffs due to [Mandatory COVID-19 lockdown]
SUMMARY OF ISSUE	They have had only one layoff in 28 years. This layoff occurred in March 2020 due to a mandatory COVID-19 lockdown instituted by Miami Dade County.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	126 employees were laid off, representing 95% of the company's employees at that time.
IMPACT ON STAKEHOLDERS	Primary impact was loss of employment for affected employees.
IMPLEMENTED MGT PRACTICES	When they layed off their employees, they paid out all accrued vacation, holiday, and personal leave. And continued to pay both the employer and employee portions of medical insurance throughout the lockdown. As soon as it was available, they applied for a PPP loan. On May 1, 2020, they secured a PPP loan and although they were not operational again until June 6, 2020, they rehired 117 employees (13 declined re-employment.) During the non-operational time between May 1 and June 6, 2020, they engaged their staff with the following activities: • Each pool had a weekly engagement zoom meeting with their team. • Employees were assigned online training courses and were asked to also choose self-improvement classes activities to fill their regularly scheduled hours. • Managers sent encouraging gifts, letters, and postcards to the team. • They organized team 'drive-by's' to celebrate team members' birthdays and graduations. • They assisted their employees by writing letters confirming layoffs and requesting rent reductions. • They also assisted employees by helping them apply for unemployment compensation.
MANAGEMENT COMMENTS	Ocaquatics takes it's responsibilities towards and dedication to its team of employees very seriously. They regret that during the initial uncertainty of the COVID-19 pandemic, they had to make the decision to layoff employees in order to ensure the survival of the business.
