



## DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

<b>SUMMARY OF ISSUE</b>	As a provider of zipline tours, Skyline Eco-Adventures has experienced three guest injuries that resulted in lawsuits over the last five years.
<b>SIZE/SCOPE OF ISSUE</b> (e.g. \$ financial implication, # of individuals affected)	The total settlements paid to date are equivalent to less than 5% of the company's annual revenue. In the last five years, the company has hosted over 375,000 zipline tour guests, and only three guests experienced injuries that resulted in litigation.
<b>IMPACT ON STAKEHOLDER(S)</b>	Guests in these cases have experienced broken bone injuries during the company's zipline tours.
<b>RESOLUTION</b>	Two of the lawsuits were filed in 2016, and were settled via the company's General Liability Insurance. One lawsuit filed in 2018 is still pending.
<b>IMPLEMENTED MGT PRACTICES</b>	Skyline Eco-Adventures works to improve the safety of its tours on an ongoing basis, including the addition of new safety features as they become available.
