SUMMARY OF ISSUE	Oak Bay Luxury Getaway is located in the Georgian Bay Biosphere which is the largest freshwater archipelago in the world. The Township of Georgian Bay and the Oak Bay Golf Course (located close to the rental) are designated Bee City locations.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	100% of the company facilities are located in the Georgian Bay Biosphere.
IMPACT ON STAKEHOLDERS	By operating in a biosphere, the risk is to many travellers and the carbon footprint left behind with constant use of the facility. To mitigate this we need to be conscious of how we operate, and how we educate the travelling public. Talking to our guests about snakes and turtles, and how to respect them if there is an encounter is important. It is equally important that we educate about what guests bring, be it water bottles, excess packaging. We also spend a great deal of time talking about reducing our carbon footprint by encouring the collection of food waste with our guests. We have a bin in the kitchen and also in the garage. We weigh food waste and recycling at the end of each visit.
IMPLEMENTED MGT PRACTICES	To mitigate the risk of negative environmental impact, the company conducts a comprehensive carbon audit each year to track and consciously reduce GHG emissions. They also do not use any pesticides or chemicals for pest control on their premises, in an effort to protect pollinators. They only use organic stone on the exterior of the rental house that is free from glue and fillers. The company also tracks water usage and waste production
