Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Disclosure Questionnaire Category: Other - Clients in Controversial Industries

Topic	Clients in Controversial Industries
Summary of Issue	The company is a web hosting and maintenance company that has had clients in the water utilities industry. The nature of the company's services with clients in these industries has been related to website hosting, maintenance and development. All services can be sold to both controversial as well as non-controversial industries.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	The revenue from clients in the water utilities industry represented 6.65% in FY22-23.
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemented Management Practices	The company avoids potential clients in sensitive industries and introduces policies and procedures to assess client suitability based on their value alignment. The company will no longer take on new development work for their clients involved in the water utilities industry. The company gets new clients to complete a questionnaire as part of the sales process. This questionnaire covers the five areas in the B-Corp standards (Governance, Workers, Community, Environment, Customers) and the company will assess the client's score before deciding on taking on the client. The company requires their clients to sign their code of conduct during our onboarding process.

Management Comments	The company is confident that the measures they have put in place to assess and review client suitability will ensure that Vu Online does not engage with clients in controversial industries in the future. The company is also confident that the work they have done for Water UK has helped their clients to increase data transparency in the water sector and that their involvement has not aided the growth of water companies.
