Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Topic	Litigation related to unsafe working conditions
Summary of Issue	The public organization in charge of work conditions and safety (OEITSS) set a penalty for the company for 3 accidents that occurred to the employees in the workplace during worktime
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	The estimated value of all claims and penalties amounted to 0.003% of the company's revenue in the last fiscal year.
Impact on Stakeholders	The primary stakeholders affected were employees who reported injuries and associated physical and emotional impacts.
Resolution	The settlement has been finalized with payment by the company. The 3 cases were settled with payment by the company.
Management Practices	To mitigate new issues in the future, SOMOS HIJOLUSA developed and improved the following practices: <ul style="list-style-type: none">• Dedicated lanes have been designed for machinery to travel along, thereby improving signage and visibility within the factory.• New measures have been implemented: truck drivers must leave their keys in the company's safekeeping until unloading is complete and must remain in a separate room.• Barriers have been installed along the entire walkway, thereby blocking access to the hopper area where the potatoes became jammed.

Summary of Issue	SOMOS HIJOLUSA S.L. is a leading Spanish agri-food business group specializing in cultivating, washing, sorting, packaging, and marketing high-quality potatoes and horticultural products. The company imports potatoes from Israel, which is a conflict zone. The company sources directly from Israel. (Tier 1)
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	In the last fiscal year, the company's potato purchases from Israel represented 2.5% of total purchases.
Impact on Stakeholders	<p>Business activities located in conflict zones are considered high-risk as they are more likely to cause or contribute to the conflict and/or sociopolitical instability.</p> <p>Countries classified as conflict zones are more likely to have a weak rule of law or a corrupt judicial system, which could undermine the effectiveness of operational grievance mechanisms for these businesses and their suppliers. In addition, the safety of the company's workers and other potential human rights violations are at risk.</p>
Implemented Management Practices	<p>All suppliers hold a valid GLOBAL G.A.P. certification. This scheme entails independent external audits covering food safety, traceability, good agricultural practices, sustainability, and legal compliance. It constitutes a verification performed by a competent and internationally recognized third party.</p> <p>All suppliers need to comply with the company's Code of Ethics. This Code of Ethics establishes the principles and standards that must guide the professional conduct of all individuals who are part of the Group, as well as those third parties who interact with it, with the aim of preserving its reputation, ensuring responsible management, and reinforcing the trust of clients, suppliers, and society in general.</p> <p>The Code of Ethics applies to the personnel comprising the Group at all levels—whether temporary or permanent staff—and</p>



	<p>regardless of the hierarchical position they hold. Likewise, it shall also apply to partner companies, external personnel, and/or clients.</p> <p>Compliance with this Code of Ethics is mandatory; it must be accepted by any individual joining any of the entities that comprise the SOMOS HIJOLUSA Group.</p> <p>SOMOS HIJOLUSA is committed to acting, at all times, in accordance with applicable legislation, while maintaining full respect for human rights and civil liberties. In this regard, all individuals falling within the scope of this Code must act with integrity in all their dealings. Furthermore, they must avoid any conduct that—even if it does not violate the law—could harm the Group's reputation or negatively affect its interests.</p> <p>The Group maintains a zero-tolerance policy regarding any form of corruption, bribery, fraud, or unfair practice.</p> <p>SOMOS HIJOLUSA has a whistleblower channel which guarantees the anonymity and confidentiality of the information, as well as impartiality and objectivity in the assessment of cases, respect for the rights of all parties involved, and the absence of retaliation against whistleblowers who submit reports in good faith.</p>
