Disclosure Questionnaire Category: Other - Clients in Controversial Industries

Topic	Clients in Controversial Industries
Summary of Issue	Dragon Army is a digital engagement company that provides web development, mobile development, and content & branding services.
	The company has a client that has a division in bottled water. B Lab deems this industry controversial. The services offered to the client relate to digital marketing strategy, providing design and development resources. Dragon Army has never worked directly with the bottled water division of its client and has so far only provided its services for other products of its client.
	The services provided to the client can be sold to other clients in different industries, including other non-controversial industries, although it is tailored from client to client.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	In the fiscal year of 2024, the company had generated 9% of its total revenue from Bottled Water companies.
Impact on Stakeholder(s)	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry.
	B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemented Management Practices	Dragon Army avoids clients in highly sensitive industries that do not align with the company's purpose, vision, tenants and values and these would include businesses that promote, manufacture or invest in harmful products to consumers. As such, the company would not work with clients from the tobacco, firearms and pornography industry.



Before Dragon Army initiates contracts or prospecting discussions with potential clients, they would review the leadership, history and financials of the company that they may engage with.
