



DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

IMPLEMENTED MGT PRACTICES	<p>The company adheres to a number of global and local guidelines when working with alcohol brands. The company works alongside the local government requirements, and also voluntarily applies the Portman Code of Practice on the Naming, Packaging and Promotion of Alcoholic Drinks to ensure that alcohol is marketed in a socially responsible way, only to those aged 18 and over, and in a way that does not appeal particularly to those who are vulnerable.</p> <p>In the events organised by the company, they ensure that there is an enforceable age requirement (over 25) for attendance. The company does not include anyone under 25 in any imagery or videography. The company trains any promotional staff to recognise and challenge the consumer for age. The company's creative work does not glorify alcohol and the same is stress-tested by the company for age to ensure it has only an adult appeal and supports responsible use.</p> <p>Further, the company conducts quarterly training sessions on the alcohol marketing guidelines, in line with internal policies and that of their clients. They company also has a minimum 4 stage sign off process to ensure all work passes those guidelines.</p>
