Disclosure Materials

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Summary of Issue	<p>Freerange Future has clients in the following industries: Charity Lottery.</p> <p>The types of services offered to these clients include:</p> <ul style="list-style-type: none">- Digital marketing services
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	In the last fiscal year, 4.30% of the company's annual revenue was from clients in the Charity Lottery industry.
Impact on Stakeholder(s)	<p>Companies that work with clients in controversial industries can directly or indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry.</p> <p>Companies offering certain types of services and products to controversial clients are required to have at minimum a grievance/complaints mechanism and a whistleblower protection policy.</p>
Implemented Management Practices	<p>Freerange Future has the following mechanisms in place to manage the risks associated to serving clients in the controversial industries:</p> <p>Grievance/complaints mechanism. This is accessible to the public through a Grievance Policy available on the company's website. The person managing the grievance will contact the complainant to acknowledge receipt and begin discussion, typically within 2 working days of receipt. The individual or team involved in the grievance will be informed of the concern and given a fair opportunity to respond. Relevant information and evidence, including witness statements if applicable, will be gathered. The initial investigation process will generally be completed within 10</p>

	<p>working days. The parties involved will be informed of the outcome and next steps. If a stakeholder is not satisfied with the outcome, an appeal may be lodged within 3 working days to the Managing Director for further review. A grievance may also be escalated to an appropriate external body (e.g., an ombudsman, regulatory body, or legal entity), and doing so will not prevent Freerange Future from continuing its internal grievance process if appropriate.</p> <p>Whistleblower Protection Policy. Freerange Future is committed to fostering a culture of integrity, transparency, and accountability. This includes providing a safe and confidential environment for employees, contractors, or other stakeholders to report misconduct, unethical behaviour, or illegal activities without fear of retaliation.</p> <p>If retaliation against a whistleblower is identified, Freerange Future will take immediate and decisive action. This includes, but is not limited to:</p> <ul style="list-style-type: none"> - Disciplinary measures against individuals found responsible for retaliatory actions, up to and including termination of employment. - Reporting serious incidents to external regulatory bodies or legal authorities. - Implementing additional measures to safeguard the whistleblower from further harm. <p>To uphold whistleblower protection, Freerange Future is putting the following mechanisms in place:</p> <ul style="list-style-type: none"> - A confidential reporting system to ensure whistleblower identities are protected. - A secure communication channel for whistleblowers to provide updates or raise concerns about retaliation. - Regular training for managers and staff on whistleblower protection and anti-retaliation measures. - A monitoring system overseen by the Managing Director to track the outcomes of disclosures and address any risks of retaliation.
