



DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

TOPIC	Litigation related to unfair dismissal
SUMMARY OF ISSUE	DSG Group has had 2 lawsuits in the past 5 years, one in August 2017 and another in December 2020. Both employment tribunal cases against the entities of DSG Group, where initially, alleging unfair dismissal brought up by a former employee.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	The value of the settlement in both cases was less than 0.1% of the annual revenue of DSG Group
IMPACT ON STAKEHOLDERS	The stakeholders affected in the litigation cases were the former employees that initiated the litigation process
RESOLUTION	The 2 litigation cases were settled prior to a full court meeting, following participation in formal arbitration. Both cases are closed, with no appeal possible by either side.
MANAGEMENT PRACTICES	As result of the mentioned lawsuits, DSG Group has invested in and developed its HR expertise to both ensure that performance management process are fit for purpose, and to also support its staff. This includes making provision for the support of all staff with known or possible vulnerabilities, including disabilities. DSG Group has also recruited subject matter experts in relation to HR and staff well-being. The addition of specialist staff has allowed the company to revise its policies and processes in relation to how staff are managed. Where required, new policies and processes have been implemented to both protect our business and to support our staff.
RELATED INCIDENTS (YES/NO)	In the last 5 years, the company has only had the 2 lawsuits mentioned above.
