Disclosure Materials

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

B Lab's Public Complaints Process

Any party may submit a complaint about a current B Corp through B Lab's Public Complaint Process. Grounds for complaint include:

- Intentional misrepresentation of practices, policies, and/or claimed outcomes during the company's certification process
- 2) Breaches of the B Corp Community's core values as expressed in our Declaration of Interdependence

Summary of Issue	Recognition Industries has clients in the following industries: Tobacco.
	The types of services/products offered to these clients include: • B2B customer loyalty/engagement platform.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	In the last fiscal year, 8% of the company's annual revenue was from clients in the tobacco industry.
Impact on Stakeholders	Companies that work with clients in controversial industries can directly or indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry.
	Companies offering certain types of services and products to controversial clients are required to have at a minimum a grievance/complaints mechanism and a whistleblower protection policy.
Implemented Management Practices	Recognition Industries has the following mechanisms in place to manage the risks related to its business relationships with clients in controversial and ineligible industries:
	Grievance/complaints mechanism. This is accessible to the public through dedicated email addresses (complaints@winwin.ie or feedback@digibreaks.com), customer service phone line (+353 1 667 5377), and online complaint forms available on brand websites. Stakeholders submitting a complaint receive an automatic confirmation within two (2) business days, and a formal response is provided within five (5) to seven (7) business days. If the issue cannot be resolved within this given timeline, the company continues engaging with the whistleblower until they are able to reach an outcome.



	 Whistleblower Protection Policy. The policy includes the following statements: The WIN WIN Group (comprising Recognition Industries Ltd, Scream Ltd, Digibreaks Ltd, and Hospitality Concepts Ltd) is committed to maintaining a workplace that upholds integrity, transparency, and ethical conduct. We recognize the critical role whistleblowers play in safeguarding our organization from misconduct and are dedicated to ensuring they are fully protected from any form of retaliation. To support whistleblowers, the WIN WIN Group has implemented strict anti-retaliation measures. Any form of retaliation, including dismissal, demotion, harassment, discrimination, or other adverse actions against whistleblowers, is strictly prohibited. Violators of this policy will face serious disciplinary consequences, including termination and potential legal action. The WIN WIN Group is fully committed to compliance with the Criminal Justice (Corruption Offences) Act 2018 and fostering a culture of honesty and openness. Employees are encouraged to report any concerns regarding bribery, corruption, or unethical conduct to their manager or designated reporting official. Any such disclosures will be handled with the utmost confidentiality and in the best interest of the public and the organization.
