Disclosure Questionnaire Statement

Disclosure Questionnaire Category: Litigation, Arbitration, Penalties, and/or Regulatory Complaints

CAMPER GROUP reported having two material penalties filed against the company related to the following issues: consumer protection. Those cases had repercussions in the last five years.

Legal disputes, arbitration, penalties and regulatory complaints can adversely affect external stakeholders by disrupting customer service, causing uncertainty and financial negative impacts for suppliers and employees, and diminishing investor confidence. Additionally, these issues may damage the company's reputation, and result in broader economic and regulatory repercussions. Certified B Corps must make their involvement in Litigation, Arbitration, Penalties, and Regulatory complaints transparent under their B Corp Profile.

Topic	Company has suppliers located in Conflict Zones
Summary of Issue	Camper Group is a prominent shoemaker based in Mallorca Spain with operations in many countries. In the current fiscal year, they have engaged a company providing marketing services which is based in Russia, listed as a conflict zone in Global Conflict Tracker. Camper Group does not have any direct operations in Russia.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	In the current fiscal year, less than 0.2% of the company's procurement budget will be on marketing services originating from Russia.
Impact on Stakeholder(s)	Business activities located in conflict zones are considered high-risk as they are more likely to cause or contribute to the conflict and/or sociopolitical instability. Countries classified as conflict zones are more likely to have a weak rule-of-law or a corrupt judicial system, which could undermine the effectiveness of operational grievance mechanisms for these businesses and their suppliers. In addition, the safety of the company's workers and other potential human rights violations are at risk.
Implemented Management Practices	Camper Group maintains a robust supplier screening, assessment and compliance protocol, as disclosed in the BIA, which includes, among others: -Due diligence checks for ethical and legal compliance, including assessments of geopolitical risk. -Minimum social and environmental standards outlined in their supplier code of conduct. This is detailed in the company's Sustainable Procurement Guidelines/Purchasing Policy.
