<b>Topic</b>	Media Coverage
<b>Summary of Issue</b>	The background check process report revealed news in the past 5 years demonstrating stakeholders' concerns involving the Azura Group's operations in Western Sahara, an area that has historically been disputed.
<b>Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)</b>	The group operates in the Dakhla Oued Ed-Dahab region through two production sites in the area. One production site is located around 10km North of Dakhla's peninsula. The second facility operates 10km East of Dakhla's White Dune. These sites represent approximately 25% of the company's total cultivated land area. Around 4,700 workers (full-time equivalent) live and are active in these areas. Approximately 30% of the group's full production areas (volume) comes from that region, generating around the same 30% of its annual revenue.
<b>Impact on Stakeholders</b>	Business activities located in historically disputed and conflict areas are more likely to face sociopolitical instability and a weak rule of law, which could undermine the effectiveness of operational grievance mechanisms for these businesses. The potentially impacted stakeholders are workers, the local community, and businesses competing in the same market as the company sells its products. The safety of the company's workers and other potential human rights violations, are at risk, including other types of potential risks associated with a historically unregulated market.
<b>Implemented Management Practices</b>	Through Dakhla's operations, Azura contributes to the local economy and social environment by providing conditions aligned with the group's standards: structured and formal employment conditions, the provision of accommodation within its facilities where relevant, and remuneration aligned with internal practices. Its Code of Conduct has been implemented across all production sites, including Dakhla, and it is supported by established employment practices and other internal regulations. The group-wide framework addresses potential risks, and it's overseen by local management.

	<p>There is a formal whistleblowing and grievance mechanism detailed in the Code, including a structured investigation process, protection against retaliation, and a confidential channel that allows employees and stakeholders to report concerns. Key principles of the Code are displayed across all sites to ensure accessibility and awareness. Alerts are handled by the audit team and escalated to the ethics committee, if needed. Anticompetitive practices are forbidden, and this requirement is extended to suppliers via the Supplier Code of Conduct. The Code of Conduct covers ethics, anti-corruption, and conflicts of interest. Any form of corruption, undue advantage, or inappropriate political contribution is prohibited.</p> <p>The Azura Group complies with the European and Moroccan laws and regulations for its activities. The legality is confirmed by the <a href="#">EU-Morocco agreement of October 3, 2025</a>, which maintains the application of EU tariff preferences to products from Morocco's Southern Provinces: products from Dakhla Oued Ed-Dahab continue to benefit from the tariff preferences agreed upon between the EU and Morocco, just like products from Agadir. In addition, <a href="#">the Azura Foundation</a> has carried out projects in education, sustainable management of natural resources, and capacity building for the local community in which Azura is active, including Dakhla, for more than 10 years.</p>
<b>Management Comments</b>	<p><i>On October 31, 2025, the United Nations Security Council adopted a <a href="#">resolution</a> in favor of the Moroccan autonomy plan for the Sahara as the sole basis for negotiations to resolve the international dispute.</i></p>
