Disclosure Questionnaire Statement

Disclosure Questionnaire Category: Industries at Risk of Human Rights Violations

Topic	Forced labor and human rights violations are recognized as material issues in the jewelry industry.
Summary of Issue	TLKE Limited is a distributor of timepieces and jewelry that earns a material amount of revenue from raw materials whose supply chain carries risks of human rights violations which includes jewelry & precious metals.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	11.2% of TLKE Limited revenue comes from the sale of jewelry made from precious metals. This includes after sales services which encompasses brand training and marketing support.
Impact on Stakeholder(s)	The global jewelry & precious metals industry has a history of forced and child labor, which subjects workers to poor working conditions, low wages, and puts children at risk for human trafficking.
Implemented Management Practices	- Supply Chain Traceability: TLKE can trace 100% of the metals used in its products back to the refiner level. All primary input materials, including silver, are certified as recycled. - Supplier Screening and Evaluation: TLKE maintains a comprehensive supply chain policy for direct suppliers. A due diligence process is completed during supplier onboarding, requiring proof of material origin. The company has mapped its entire metal supply chain and verified supplier claims through third-party certifications. - Human Rights and Forced Labor: TLKE has declared that, to the best of its knowledge, there are no instances of forced labor or human rights violations in its supply chain. All suppliers comply with recognized standards such as the Social and Labor later Convergence Program or the Responsible Jewelry Council Code of Practice. TLKE's Supplier Code of Conduct which includes policy on human rights forms part of their standard contract issued to suppliers.
