Between 2023-2020 fiscal period, the company has worked with clients in the Defense and/or Offensive Firearms, and Weapons, but since 2024 has decided to discontinue working with this industry. The company's services can be sold to both controversial as well as non-controversial industries.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	From the company's FY2023 annual revenue: -Clients operating in the Defense and/or Offensive Firearms, and Weapons industry represented 0.1% -Clients operating in the Fossil-fuels (other) industry represented 1% -Clients operating in the Alcohol industry represented 2% -Clients operating in the Banking in Switzerland industry represented 5% -Clients operating in the Tax Advisory Services industry represented 2%
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards.
