Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Topic	Company serves clients in Controversial Industries
Summary of Issue	Scott Logic is a company that provides software consultancy to clients, including in controversial industries such as fossil fuel companies. The same exact services provided to clients in the controversial industry are sold to clients in non-controversial industries. The custom software Scott Logic builds improved operational accuracy, measurability, transparency and auditability.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	11.89% of Scott Logic's revenues in 2022 has been from clients in the fossil fuel industry. The company revenues associated with clients in the fossil fuel industry is based on a flat rate - regardless of profits derived from the consultancy offerings. The company has an ongoing engagement with these clients.
Impact on Stakeholders	Companies that offer products/services to clients in controversial industries may be contributing to the controversial impact of those industries.
Implemented Management Practices	All current and future work related to clients in controversial industries is validated using Scott Logic's Ethical Risk Framework. The company will continue working with these clients in this controversial industry, provided the specific work does not directly relate to fossil fuel extraction or refinement.
