Topic	Clients in Controversial Industries
Summary of Issue	Link Up has been serving clients in the Alcohol, Pharmaceutical, Charity Lotteries and Marketing of Breastmilk Substitutes industries by offering services such as communication and CSR strategy, and roll-out services. Their services can also be sold to non-controversial industries.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	6.87% of revenue comes from the alcohol industry in 2022. 0.9% of revenue comes from the charity lottery industry in 2022. 9.07% of revenue comes from the Marketing of Breastmilk Substitutes industry in 2019. 1.07% of revenue comes from the Pharmaceuticals industry in 2019.
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemented Management Practices	The company developed methodology to screen their current commitments and assess the potential client's impacts on environment, on GHGE and on social issues using internal interviews, third parties meeting (including NDOs) and regulatory context; It sorts out the challenges and consider relevant sustainable topics thus underpinning how they must reinforce their policies in order to build concrete progress roadmaps and KPis.
	The company sets KPIs to make their clients follow up the progress and report it within the CSR report. The company does not require their clients to sign a code of conduct, but many of their clients already have one.
	The company no longer works for Marketing of breastmilk substitutes industry.
