IMPACT ON STAKEHOLDERS	Cannabis and cannabis related products are subject to controversy both because of their current and historic legal status around the world, as well as concerns about the potential harm that the products may cause.
	Current regulations governing the legality of cannabis-related products are complex across the world and vary by jurisdiction.
	While the risk of criminal prosecution may be low or negligible, B Lab encourages consumers, retailers, and manufacturers to conduct their own research based on individual circumstances to determine the legality of certain marijuana-related products in one's jurisdiction.
IMPLEMENTED MGT PRACTICES	Naturalpes fully complies with pertinent regulations pertaining to the sale of cannabis derived products in each country of sale.
	The company routinely tests their products in Swiss accredited laboratories to ascertain that their products don't exceed the 1% THC limit in Switzerland and the 0.2% THC limit in the rest of Europe. Natualpes has strict controls of each of their batches before the release of the products on the market.
	The company is certified ISO 9001 since the audit performed on September 8, 2021. The quality management system, provides quality management and ensures that the company meets the needs of customers and other stakeholders in compliance with legal and regulatory requirements. The procedure of the regulatory watch PRO 1001-20 obliges the company to follow the evolution of the laws in each field in which Naturalpes works and to comply with them. The company continuously monitors regulatory developments in Switzerland and Europe through its member associations, IG Hanf in Switzerland, EIHA and the Swiss Cosmetics Association, which keep the company informed of the latest legislative developments.
	To address the risks related to products that are smokable, the company warns of the dangers caused by smoke on the packaging of flowers intended for combustion and recommends that customers use alternative means of consumption such as vaporizers or CBD flower infusions.and recommends the use of other means of consumption such as vaporizers or CBD flower infusions. When selling dried flowers in their physical shops, they check the age of their customers by asking for their ID to make sure that they are of legal age. On their website, they ask for a confirmation of the age through a pop-up when one arrives on their website.
	Naturalpes does not make or sell any medicinal or recreational marijuana products.
