



DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

TOPIC	Company sources and retails animal products.
SUMMARY OF ISSUE	Sea to Table is a seafood company based that sources and retails seafood products. The company partners with local fishermen from small-scale sustainable wild fisheries, finding better markets for their catch and supporting traditional fishing communities.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	~99% of Sea to Table's revenue is comprised of sales of seafood products.
IMPACT ON STAKEHOLDERS	The seafood industry may have negative environmental impacts on their affected marine ecosystems, e.g., overfishing, loss of biodiversity, pollution. Furthermore, the seafood industry is at risk of human rights violations in their supply chains.
IMPLEMENTED MGT PRACTICES	Sea to Table is MSC Chain of Custody certified. In addition, the company sources from fisheries that are MSC Certified. Sea to Table currently earns 73% of E-Commerce Revenue and 94% of Wholesale Revenue from MSC certified fisheries. The company is able to trace 100% of products back to the source. Sea to Table has a rigorous Vendor on boarding process that includes vetting MSC certification, USA product only, and an agreement that states that suppliers follow all of the stringent labor laws set forth by US regulations. All of the company's products are USA caught and Processed. As such, all vendors must follow US Labor Laws.
